1. Launch of 2024/25 Prescribing Efficiency Scheme (PES)

We are pleased to announce that the Prescribing Efficiency Scheme (PES) for 2024/25 was officially launched on 24th May 2024. Please follow the <u>link</u> to the GP portal for full details and the associated launch webinar.

The PES for 2024/25 is in two parts and no submissions are required from practices.

- Part One: Review prescribing of blood glucose testing strips (BGTS) to be in line with NHSE and NEL ICB guidance/recommendations.
- Part Two: Work with your NEL ICB Pharmacy and Medicines Optimisation Team to deliver a practice specific prescribing Cost Improvement Plan (CIP).

This year's PES is designed to be personalised to each practice to ensure CIPs reflect individual practices' current prescribing patterns and savings opportunities. As always, the NEL ICB Pharmacy and Medicines Optimisation Team will work closely with practice staff and PCNs to provide the support needed to help deliver the targets set within the PES. Your place lead medicines optimisation pharmacist is looking forward to your initial meeting to discuss the new and innovative approach to this year's PES.

We are working with selected 3rd party providers (funded via pharmaceutical company donations) to provide practices and PCNs, with extra pharmacy workforce capacity to support the delivery of the 2024/25 PES. This offer is being made to all NEL practices, who will be free to decide if and how they use this any additional support.

5. Serious Shortage Protocol – Creon® Capsules

A national Serious Shortage Protocol (SSP) has been issued for Creon® 10000 capsules and Creon® 25000 capsules.

The SSPs will restrict the amount of these medicines that can be provided to patients to one-month's supply. Under the SSP regulations, patients who receive less medicine when supplied in accordance with these SSPs will not have to pay prescription charges.

Both SSPs came into effect on Friday 24th May 2024, and are scheduled to come to an end on Friday 22nd November 2024.

6. Influenza Season 2023/24: Ending the Prescribing and Supply of Antiviral Medicines in Primary Care

The most recent surveillance data from UK Health Security Agency (UKHSA) indicated that the circulation of influenza in the community has returned to baseline levels.

In accordance with NICE guidance and Schedule 2 to the National Health Service (General Medical Services Contracts; Prescription of drugs etc.; Regulation 2004), commonly known as the Grey List or Selected List Scheme (SLS):

- GPs and other prescribers working in primary care should no longer prescribe antiviral medicines (including neuraminidase inhibitors) for the prophylaxis and treatment of influenza on an FP10 prescription form.
- Community pharmacists should no longer supply antiviral medicines in primary care on presentation of an FP10 prescription form.

This does not impact on prescribing of antiviral medicines in hospitals, where prescribing can continue in line with relevant guidelines.

7. Lisdexamfetamine - Medicines Supply Notice

The DHSC has released a Medicines Supply Notice (MSN) for lisdexamphetamine. Please see MSN 2024 051 Lisdexamfetamine Elvanse capsules.pdf

Although it implies national stocks may be available, please note that local supply chains may still be affected.

First port of call for stock information remains at the SPS <u>Prescribing available medicines to treat ADHD – SPS - Specialist Pharmacy Service – The first stop for professional medicines advice</u>

Although it does suggest unlicensed sources could be available, please note the GMC ethical guidance on prescribing unlicensed medicines, when prescribing an unlicensed medicine and lead times for supply may vary greatly.

Eye preparations	Guidance on prescribing, cost-effective treatment options and self-care for glaucoma and dry eye.
Antiepileptic drugs	Includes new valproate safety information, and support to appropriately switch antiepileptic drugs (AEDs) to safer or less costly alternatives.
Silk garments	Supports the implementation of NHS England (NHSE) guidance on items which should not be routinely prescribed in primary care.
