

What is Practice Level Support?

Practice Level Support provides pragmatic, hands-on support for practices using experienced primary care quality improvement specialists who have worked with general practice for many years.

Practices who have participated in the programme to date have outlined:

- · better alignment between capacity with demand
- improvements to their local access systems and care navigation processes
- · an improved working environment for staff
- · improvements in patient experience.

The offer, available through the national General Practice Improvement Programme. consists of up to 16 on-site visits and four group-based sessions over a 4-6 month period. The support helps practices move towards the ambitions laid out in the Delivery Plan for Recovering Access to Primary Care and a modern general practice model.

Practice Level Support – Information for **London** Practices

How does it work?

A nominated GPIP facilitator will be assigned to a small cohort of practices from one (or if applicable two neighbouring) ICB(s). They will separately meet with the nominated leads from each practice to agree ways of working, looking to accommodate where possible the practices' preferences.

Celebration Learning Event

The first four on-site visits are diagnostic sessions to determine how to help the practice make maximum progress across one or more areas. Remaining sessions will support the practice to implement change. Support concludes with a celebration / learning Event where other local practices will be invited to listen and learn.

Following the initial delivery of up to 4 months support there is an opportunity for an additional 3 or 6 on-site visits, or 2 months of support, for each practice where that would help support further change. This will be dependent upon capacity. Practices who sign up are not required to take up this additional offer.

Who can access Practice Level Support?

All practices are encouraged to consider whether practice level support would be beneficial for them, and are welcome to apply. However, given the time limited nature of the programme, it may not be appropriate for practices who are already receiving significant ICB support, such as those that have been rated as inadequate by CQC.

Why should my Practice get involved?

The programme supports practices move towards the Modern General Practice model, which will enable practices to be fairer, safer and more sustainable. 1000+ practices have taken part in Practice Level Support so far, enabling them to plan and deliver improvements. The programme consistently receives excellent feedback.

Is there funding for practices who participate?

The hands-on support from the GPIP facilitators is fully funded by NHS England. There is no backfill funding available to support practice staff engage with the programme, however, participation may enable your practice to achieve the outcomes required to access <u>practice Transition</u> funding, or <u>PCN Capacity and Access Improvement Payments</u> from your ICB.

There are a limited number of places available nationally that are being offered on a first-come-first-served basis. The national GPIP programme aligns to the <u>Delivery plan for recovering access to primary care</u> which runs until March 2025. It is unlikely that there will be any future cohorts and so practices are encouraged to make use of one of the three upcoming cohorts this year.
