1. Community Pharmacy Selfcare Advice Service (CPSAS)

On 1st July 2024, NHS North East London (NEL) ICB will be launching the Community Pharmacy Selfcare Advice Service (CPSAS).

This service has been enabled, for 2 years, by Population Health and Integration 'shared ambition' funding, to help reduce health inequalities in NEL. This is a priority in the current context of significant health inequalities within our population, with those living in more deprived areas experiencing poorer health outcomes, and high cost of living pressures across NEL.

Under the service, any registered NEL community pharmacy can provide support to socially vulnerable residents to self-manage their minor ailments with clinical advice, sign posting / referral to health and wellbeing services and where indicated free over the counter (OTC) medicines.

4. TARGET

TARGET stands for Treat Antibiotics Responsibly, Guidance, Education and Tools. It is a toolkit designed to support primary care clinicians to champion and implement antimicrobial stewardship activities.

Developed by the UK Health Security Agency (UKHSA), the Royal College of General Practitioners (RCGP) and the Antimicrobial Stewardship in Primary Care (ASPIC) Group, TARGET is the central resource to help primary care healthcare professionals and commissioning organisations improve antibiotic prescribing.

A number of resources are available on the website <u>TARGET antibiotics toolkit hub | RCGP Learning</u> to support antimicrobial stewardship in your practice, including audit templates and tools to support reviewing patients on long term and repeat antibiotics, self-assessment checklists, action planning templates and posters and videos for clinical waiting areas as well as 'Treating Your Infection' leaflets for common infections which are available in 25 languages. The available resources can also be used to support CPD and revalidation requirements.

We encourage all community, general practice and PCN pharmacists as well as other prescribing leads to <u>Sign</u> to the Target quarterly newsletter.

5. Reformulation of Aymes Complete® (now known as Actagain 1.5 Complete®)

Aymes have reformulated Aymes Complete and this Oral Nutritional Supplement (ONS) product will now be known as Actagain 1.5 Complete. Actagain 1.5 Complete was launched on the 1st June 2024.

Aymes Complete is a ready to drink milkshake style ONS on the NEL formulary as a second line option to powdered ONS (for patients who cannot tolerate powdered ONS). This formulary status is extended to remain for Actagain 1.5 Complete.

The key changes in this reformulation are that there is an increase to 14g of protein and an increase to 5 micrograms of vitamin D per 200mL bottle. The datasheet for the nutritional analysis of Actagain 1.5 Complete will be available here. The price remains the same as Aymes Complete at £1.11 per 200mL serving.

6. QIPP Focus: Branded Metformin MR Tablets

Prescribing of generic Metformin modified-release tablets can deliver potential annual cost savings of approximately £140K across NEL

Action for practices:

- Prescribe modified release or slow release metformin in its generic form. This is more cost effective than branded generics -as illustrated in the table below
- Please switch to generic prescribing when prompted by OptimiseRx® messages or during medication reviews

7. OptimiseRx Messages Highlights – Prednisolone tablets

An OptimiseRx message has recently been enabled to promote the prescribing of Prednisolone 5mg tablets as opposed to 20mg tablets due to cost-effectiveness and to support dose tapering regimen.

This only applies to patients who have been prescribed or initiated Prednisolone 20mg tablets (both branded and generic version). The message will prompt the prescriber to issue the 5mg strength of prednisolone for prescriptions for all doses of prednisolone 5mg or higher.

8. OptimiseRx Messages Highlights - Metolazone

An OptimiseRx message has been enabled recently for Metolazone.

Metolazone preparations are NOT interchangeable due to differences in bioavailability. In line with the MHRA Drug safety Update (Jan 2023) MHRA Drug safety update the following messages have been enabled:

- The licensed Xaqua (metolazone) preparation should be prescribed when initiating patients on metolazone and tablets must **not** be divided in quarters.
- The intended brand (Xaqua) MUST be stated for patients who are on 2.5mg or 5mg tablets prescriptions.
- The licensed brand (Xaqua) is only available in 5mg strength; please refer to the MHRA alert for patients who require a dose of less than 5mg.

10. Medicines Supply Shortage - Quetiapine

Shortage of Quetiapine 150mg, 200mg and 300mg, anticipated re-supply date 30th August 2024.

Recommended actions for healthcare professionals:

- Clinicians should not initiate new patients on standard release quetiapine 150mg, 200mg and 300mg tablets until the supply issues resolve.
- Consider prescribing 25mg, 50mg and 100mg tablets, using the largest strength tablet(s) available to provide the required dose; or
- quetiapine XL prolonged-release tablets, adjusting the dose frequency to once daily, counselling patients on the change to formulation and dosing regimen, and to take the dose without food; or
- quetiapine 20mg/ml oral solution, only where tablets are not appropriate ensuring there is no intolerance to the excipients; and
- if the above options are not considered appropriate, advice should be sought from the patient's specialist on alternative management options.
- As a reminder to all healthcare professionals please document any changes made on patient records in response to any supply shortages.

Avoiding Look Alike Sound alike (LASA)	Guidance on minimising the risk of LASA prescribing errors occurring due to similarities between medicines, which can result in patient harm.
Lidocaine plaster	Support implementation of NHSE guidance on items which should not be routinely prescribed in primary care and provides rationale for not initiating lidocaine plasters in new patients, and for current patients to be considered for discontinuation of their prescription for lidocaine plaster.
