## Update to provision of adrenaline autoinjectors (AAI's)

Communication was sent to GP prescribing leads in all practices across Barking and Dagenham, Havering and Redbridge on 14<sup>th</sup> August 2024 to provide an important update on the guidance on the provision of AAIs in primary care. Guidance previously issued to practices in Barking and Dagenham, Havering and Redbridge has been retracted.

The current advice for all clinicians in NEL is as follows:

- Long standing regulatory and clinical advice: recommends that patients should have immediate access to two AAI(s) due to the possibility of severe allergic reactions requiring more than one dose of adrenaline before emergency services arrives, or in cases of device failure or misplacement of the first injection.
- 2. **Availability of AAIs for children**: Children clinically eligible for AAIs must have access to at least two AAIs in and out of school settings. Schools should always have access to at least two AAI(s) to administer to children in case of anaphylaxis. It is not uncommon for primary schools to request that a pupil's AAIs be left on school premises. However, pupils must still have access to AAIs when travelling to and from school as well as at home or other out of school settings.
- 3. Quantities of AAIs to be prescribed by primary care clinicians: Parents may therefore ask for up to four AAI(s) (two for the school setting and two for out of school settings that remain with the child/young person). Clinicians can consider reducing this to two AAIs for older children where the prescriber is confident that an older child has become capable of self-administration. Any recommendations to reduce quantities of AAIs supplied must be discussed with the patient or their guardian / carer.

#### Actions for practices:

Please review your current practice policies relating to patients at risk of anaphylaxis and prescribing of AAI(s) and ensure it is in line with the above recommendations.

Ensure that all clinicians (including locum and support staff) are aware of this update. Any previous CCG guidance that contradicts the above advice must be removed from your practice's pathways, recommendations and other systems/processes in your practice.

## New NEL EMIS template for Adult Oral Nutritional Supplements (ONS)

The NEL Pharmacy and Medicines Optimisation Team, NELFT prescribing support dietitian and Clinical Effectiveness Group (CEG) have jointly developed an EMIS review template, to support clinicians with appropriate ONS prescribing. The template also signposts to relevant resources, including the NEL ONS guidelines, relevant NEL nutrition patient information leaflets, malnutrition screening tools (eg MUST, SANSI), and information on referring patients to NEL dietetic community teams.

Practices can access the template by searching for: **RP NEL Adult ONS CEG v1**. The template can also be accessed via the F12 protocol (for practices that use this method).

A version for SystmOne is in development and will be available soon.

#### Action for practices:

Clinicians are encouraged to utilise the template when initiating and reviewing ONS in adults. Use of the template will also support practices with the Prescribing Efficiency Scheme.

## Attention Deficit Hyperactivity Disorder (ADHD) medication shortages

## **Prescribing Efficiency Scheme (PES) updates**

#### Second Practice Prescribing Visits from the Pharmacy and Medicines Optimisation Team

The Pharmacy and Medicines Optimisation Team will be contacting practices to arrange a second prescribing visit. These second meetings will focus on discussing progress against the individual practice cost improvement plans as well exploring any additional opportunities. A reminder for practices that ≥ 40% of your individual practice cost improvement targets should be realised by 31<sup>st</sup> October 2024.

#### Medication supply issues

We are aware that there are national supply issues with some medicines. The impact of these shortages on PES will be reviewed at the end of the financial year and adjustments made where required. Due to the parameters used to calculate saving opportunities, and the temporary nature of the shortages, we are not expecting a significant impact on the scheme.

#### Blood Glucose Test Strips (BGTS) PES Target

Please note that the PES BGTS target (to achieve ≥ 50% of all BGTS items being prescribed as NHSE recommended BGTS costing <£6 per box/50 strips) does NOT include BGTS for gestational diabetes and does not apply to ketone strips.

NEL's first line blood glucose meter for gestational diabetes is Agamatrix® Wavesense Jazz Wireless with its associated test strips costing £8.74/50.

#### BGTS workstream - Type 1 diabetes option

Please note that of the eight NEL BGTS 1<sup>st</sup> line formulary choices, GlucoFix® Tech test strips are the only suitable option for patients with type 1 diabetes. GlucoFix® Tech test strips are also a suitable 1<sup>st</sup> line option for patients with type 2 diabetes. Please see here for the list of <u>recommended meters</u>.

For practices who wish to switch patients to GlucoFix® Tech test strips, and the corresponding meter, GlucoFix® Tech GK, the manufacturer can offer support with ordering new meters for this cohort of patients.

#### Third party support

A reminder that MORPh and Interface are intermediate, third-party companies providing fully funded clinical pharmacist and or pharmacy technician time to NEL practices, to support PES. These two companies receive donations from multiple pharmaceutical companies to fund the clinician time but follow the ABPI code of practice and the local NEL formulary choices. Their work provides extra capacity for practices whilst maintaining a separation between Pharma and the NHS. There is no transfer of money from pharmaceutical companies to the ICB or to practices.

#### MORPh Clinical Services – new opportunities

Please note that practices who have already completed an expression of interest form to MORPh, may be contacted with information on new opportunities, including inhalers, glycopyrronium, oxycodone and buprenorphine patch reviews. Details of these new services can be found on the <a href="#">GP Portal</a>.

These services have been reviewed and discussed with the ICB. The availability of medicines has been confirmed by the manufacturer. As always, the decision to utilise the clinical support to undertake these reviews is entirely at the discretion of the practice. ## Interface Clinical Services – new opportunities

Please be aware that Interface now offers a pen needle review service. Practices who have completed/undergoing BGTS reviews by Interface may be contacted by Interface and offered the enhanced pen needle review service. Other practices who have completed an EOI for Interface may also be contacted to be offered this new service. The service introduction can be found on the GP Portal.

This service has been reviewed and discussed with the ICB. The availability of the pen needles has been confirmed by the manufacturer. As always, the decision to utilise the clinical support to undertake these reviews is entirely at the discretion of the practice. 
# Community Pharmacy Selfcare Advice Service (CPSAS) update

The CPSAS enables participating community pharmacies to supply specific OTC medicines for a range of 24 minor illnesses, without a charge for eligible patients. This only applies when they are referred to the pharmacy from the GP Practice via Pharmacy First Minor Illness on local EMIS service. The only patients who can access CPSAS without a GP referral are those who are homeless, refugees or asylum seekers. Community pharmacies will assess patient's eligibility criteria and enrol them onto the CPSAS service accordingly. Please see full information about this service here.

GP practices will receive two notifications when CPSAS is provided following on a Pharmacy First referral. One notification will be for Pharmacy First where the consultation outcome will be categorised under 'Other', and the reason that will be provided will be 'NEL CPSAS'. The second notification is for CPSAS and this will provide you with details of the medication(s) supplied by the pharmacy. This two-step notification is currently the only way practices can be notified of the outcome of their patients' Pharmacy First and CPSAS consultations whilst avoiding double entry of medicines supplied with its associated risks of discrepancies.

We would like to thank practices for continuing referrals to pharmacies via Pharmacy First. Continued use of Pharmacy First will help alleviate pressure on practices. The availability of the CPSAS will also help reduce the need for patients, referred via Pharmacy First, to return to practices to request free over-the-counter medicines.

The ICB and the Community Pharmacy North East London (LPC) are working together to continue to offer training to practices on Pharmacy First, CPSAS and other community pharmacy clinical services. The training covers appropriate referrals and details of various services. You can book these training visits using QR codes below.
