1. Launch of the NEL Community Pharmacy Contraception Service

The Community Pharmacy Oral Contraception Service was officially launched in NEL on 27th November 2024.

The oral contraception service enables patients to have a confidential consultation with a community pharmacist to be:

- 1. Initiated on oral contraception or to be
- 2. Provided a continued supply of their oral contraception (that has been initiated in primary care, pharmacy and sexual health clinics or equivalent).

Pharmacies who provide this service will be auto populated on Local Services on EMIS (when made available), with pharmacies listed by proximity to the selected patient's home.

Please ensure:

- you obtain the patient's consent prior to making a referral and
- the choice of pharmacies where you send patient referrals to, are as per individual patient's choice.

Pharmacies will contact the patient directly within 48-72hours of receiving a referral, to agree an appointment for the consultation.

All referred patients will be assessed by community pharmacists in line with national guidelines e.g. NICE, FSRH and supply of the oral contraception will be in accordance with the national patient group directions (PGDs) for this service and the <u>NEL oral contraceptives formulary</u>.

The pharmacies who provide this service can only provide oral formulations of contraception, and not any other types such as patches, injectable and intrauterine devices. Patients who require non-oral formulations of contraception are not eligible for this service.

Other exclusions for the service include patients who are under 16 years old and assessed as not competent according to Fraser guidelines; those aged over 16 years and assessed as lacking capacity to consent.

Please refer to the individual patient group directions (PGD) for the full exclusion criteria for this service:

- PGD for the supply of a combined oral hormonal contraceptive (COC) by Community Pharmacists in England working in a pharmacy registered to provide the NHS Pharmacy Contraception Service.
- PGD for the supply of a progestogen only contraceptive pill (POP) by Community Pharmacists in England working in a pharmacy registered to provide the NHS Pharmacy Contraception Service.

UPDATE: We have been made aware that the referral function for the oral contraception service is temporarily unavailable on Local Services on EMIS.

Whilst we are in contact with EMIS Health to address this issue urgently, please continue to prescribe oral contraceptives for your patients as an interim measure.

2. Community Pharmacy Upcoming Holiday Opening Hours

There will be additional community pharmacies opening voluntarily on Christmas Day, Boxing Day and New Year's Day that are not listed in the document linked above. In addition, there will be some community pharmacies that may be closed or closing early on Tuesday 24th December 2024 and Tuesday 31st December 2024.

3. Community Pharmacies Commissioned to Provide End of Life Care (EoLC) Medicines – Upcoming Holiday Opening Hours

A reminder to all clinicians working in primary care that North East London (NEL) ICB has commissioned a designated number of community pharmacies to maintain a stock of commonly used End of Life Care (EoLC) medicines to ensure timely access to these medicines across NEL.

During the upcoming public holidays, there are six commissioned community pharmacies which will be open, however they will be operating at revised opening hours on Christmas Day, Boxing Day and New Year's Day. Information on the revised opening hours for the six commissioned community pharmacies that will be open on Christmas Day, Boxing Day and New Year's Day is provided in the table below.

Please be informed that during the Bank Holiday period, the out-of-hours service provision for EoLC medicines remains unchanged.

4. Prescribing Efficiency Scheme 2024/25 Updates

A. Metformin Monotherapy and Self-Monitoring of Blood Glucose

In the October 2024 edition of NEL Prescribing and Medicines Newsletter, the North East London (NEL) Pharmacy and Medicines Optimisation Team reported that nationally, NEL is the second highest prescriber of blood glucose testing strips (BGTS) in patients with Type 2 Diabetes Mellitus (T2DM) who are prescribed metformin monotherapy. Self-monitoring of blood glucose is not routinely necessary for non-pregnant T2DM patients who are diet-controlled or treated with metformin monotherapy as per <u>NICE Guideline [NG28] Type 2 diabetes</u> <u>management in adults</u>.

The NEL Pharmacy and Medicines Optimisation Team has produced a <u>NEL BGTS dashboard</u> which highlights the number of patients with T2DM who are diet-controlled or treated with metformin monotherapy and prescribed BGTS at GP practices within NEL. Clinicians can undertake the following steps to identify the number of patients at their GP practice:

- Open <u>NEL BGTS Dashboard</u>
- Select the tab labelled: "Oversupply BGTS"
- Using the filter at the top of the page, select "Group 1"
- Use the filter to select your GP practice and view the number of T2DM patients who are currently dietcontrolled or treated with metformin monotherapy and are prescribed BGTS.

The Pharmacy and Medicines Optimisation team have added new searches to <u>Clinical System Searches</u> on the NEL Primary Care Portal to assist with identifying these patients for a review.

Action for GP Practices:

- Use the new EMIS searches to identify patients with T2DM who are diet-controlled or treated with metformin monotherapy and prescribed BGTS. Where there is no indication for BGTS, then deprescribe. Stopping BGTS in these patients will also help GP practices work towards achieving their 2024/25 cost improvement plan (CIP) target.
- For patients with T2DM who are diet controlled or treated with metformin monotherapy and have gestational diabetes/are pregnant, then review the ongoing need for BGTS and quantities prescribed as per <u>NICE</u> <u>Guideline: Diabetes in Pregnancy</u>
- 3. Move BGTS from repeat to acute prescriptions for patients who only need to test intermittently.
- 4. Ensure BGTS are only prescribed for patients with demonstrated clinical need in line with <u>NEL Blood glucose</u> <u>test strips guideline</u>

B. Prescribing Efficiency Scheme – EMIS Search for Emollients

Following feedback from GP practices, we have reviewed the Prescribing Efficiency Scheme EMIS search for Emollients. The updated search is available in the <u>Clinical System Searches</u> folder on the NEL Primary Care Portal.

6. Primary Care Updates from NHS England

Clinicians may find the following updates from NHS England for primary care useful.

A. Influenza season 2024/25 - Use of antiviral medicines

UK Health Security Agency (UKHSA) surveillance data indicates that influenza is circulating in the community. While some areas continue to see low levels of influenza activity, surveillance indicators show that activity is increasing in all levels of care and activity is expected to increase further over the coming weeks. The most notable changes have been a significant increase in influenza positivity through laboratory surveillance and an increase in acute respiratory infection outbreaks with a marked increase in those with influenza reported, principally in care homes.

Prescribers working in primary care may now prescribe, and community pharmacists may now supply antiviral medicines (oseltamivir and zanamivir) for the prophylaxis and treatment of influenza at NHS expense. This is in accordance with NICE guidance, and Schedule 2 to the National Health Service (General Medical Services Contracts (Prescription of drugs etc) Regulations 2004), commonly known as the Grey List or Selected List Scheme (SLS).

Antiviral medicines may be prescribed for patients in clinical at-risk groups as well as anyone at risk of severe illness and/or complications from influenza if not treated.

The Chief Medical Officer and Chief Pharmaceutical Officer for England have written to health professionals through the <u>Central Alerting System (CAS)</u>, to authorise NHS prescribing of antivirals in primary care and dispensing through community pharmacy from 3rd December 2024.

B. Hormone Replacement Therapy (HRT) Prescribing Webinar
