CSAS News

During March, a total of 413,546 invites were issued, reducing by 19,000 which is the lowest number of invitations issued since November 2024. On review, this reduction is an annual trend.

Reminders increased marginally to 286,683 following two months of decline and were the lowest volumes seen since November, in November these numbers declined to 266,000.

The number of results have increased for the third month following previous reductions, a total of 303,196 results were issued in March.

Update from NHS England – Digitalisation of Screening letters

As part of plans to introduce digital communications to the NHS Cervical Screening Programme, a one-day user test will take place on **1 May**.

What's happening on 1 May:

We will attempt to send all eligible people, that were already due to be sent an invite on 1 May, a digital invite, starting with an NHS App message. It will also be flagged as an NHS App notification. If the NHS app message isn't read within 24 hours, they will then be sent an SMS (text) message directing them to a digital invite. Anyone that doesn't read the NHS app message or where an SMS (text) can't be delivered (including where people don't have a recorded mobile phone), a letter will be sent as a failsafe.

All invites will still direct people to book in the usual way.

Important notes for providers:

- No action is required from screening providers at this stage.
- This is a one-day user test only at this point. On **2 May**, the system will revert to sending letters only for now.
- The results of this test will help assure the future rollout of digital communications.
- If you do receive any queries from patients about receiving a cervical screening invite via their NHS app, please assure them this is genuine.

The goal is to make screening invitations more convenient, quicker, and cost-effective. This is a step toward a more accessible, agile, and participant-focused service. More detailed information about the wider rollout, following testing, will follow.

Manual Matching Figures

Below are the manual matching figures from February 2025 for:

'Non hits' are where participants details do not match an active record within CSMS.

The sample taker is responsible for making sure that the sample and request submitted relate to the correct person. It is essential that the sample taker checks with the individual that:

- their details on the downloaded request form are correct
- their correspondence address is current
- the personal details relate to them and are correct (such as their full name and date of birth)

If the address is not current, an address amendment should be submitted, via the GP links by the practice, of the new details as soon as possible. This will prevent downloaded results from laboratories being rejected or correspondence sent to the wrong address.

The sample taker is responsible for making sure that the person is contactable so they can be advised of any further tests or investigations needed following screening.
