1. GP Vaccination Dashboard now closed – FOR INFORMATION

The NHSE GP Vaccination Dashboard has now closed following the end of the Spring COVID-19 Vaccination Programme. The Dashboard will not be used for future COVID-19 vaccination programmes. Any sites that are not already using an alternative are advised to contact their GPIT supplier and ICB.

2. Flu and COVID-19 Seasonal Vaccination Programme: Autumn/ Winter 2025/26 letter – FOR INFORMATION

Following the [Government acceptance of JCVI's advice](#) on the COVID-19 programme, NHSE has published the [Flu and COVID-19 Seasonal Vaccination Programme: Autumn/ Winter 2025/26 letter](#).

The letter confirms the eligible groups for flu and COVID-19 vaccination for autumn/winter 2025/26, confirms the timing of the campaign (main campaign starting on 1 October, with flu vaccinations in children and pregnant women from 1 September), and lays out next steps.

As announced cohorts eligible for a COVID-19 vaccine in AW 2025/26 are:

- Residents in a care home for older adults
- All adults aged 75 years and over
- Persons aged 6 months and over who are immunosuppressed, as defined in tables 3 and 4 of the COVID-19 chapter of the Green Book ([here](#)).

3. Upcoming webinars: Choosing Your PoC supplier for autumn/winter 2025 COVID and flu vaccination campaign – FOR INFORMATION AND ACTION

To cascade to community pharmacy sites.

Community pharmacy vaccination sites must use one of the assured Point of Care (PoC) systems to record vaccinations for the AW25 COVID-19 and Seasonal Flu vaccination programmes. This provision is now commissioned under a national contract with suppliers, eliminating the need for regional local commissioning.

Successfully awarded PoC providers are undergoing assurance, with five expected to be certified for recording both Flu and COVID-19 vaccinations. Progress can be viewed here: [Community pharmacy - NHS England Digital](#)

To support pharmacy teams in supplier selection for the AW Flu and COVID-19 Campaign, we will be facilitating a week of webinars where the community pharmacy PoC suppliers will attend to provide an overview of their systems.
