## **2. Spring Summer 2026 (SS26) Training – [FOR INFORMATION AND ACTION](#)**

As we prepare for the significant changes planned for the SS26 campaign, NHS England will be delivering a comprehensive SS26 training from Monday 23 February to Wednesday 11 March 2026. This schedule includes 14 individual sessions, with a mixture of daytime and evening options to support colleagues' availability.

The Training includes:

- Dedicated FDP access drop in sessions for anyone experiencing login or system issues
- Detailed live training for all Providers
- GP Practice -specific training
- Regional and ICB focused sessions
- A dedicated session for Detained Estates colleagues

These sessions will cover key elements of the SS26 programme, including the provider led vaccine supply model, site entitlement, and allocations, ordering processes, stocktake requirements, and practical demonstrations within FDP.
